APPLA	Another Planned Permanent Living Arrangement - a federally accepted permanency plan added through the enactment of the John H. Chafee Independent Living Act.
ASFA	Adoptions and Safe Families Act - federal legislation promoting permanency for children by expediting the adoption process when return to family is not in the child's best interest.

COMAR	Code of Maryland Regulations - collection of program requirements and policies established by state mandates.
CPS	Child Protective Services - a specialized service provided by the local department of social services to children and families in situations where neglect or physical or sexual abuse are alleged.

IDEA	Individuals with Disabilities Education Act
IEP	Individual Education Plan - developed by the school system for children who need specialized educational services.
IFPS	Interagency Family Preservation Services - This service is to help prevent out-of-home placement for youth who are at imminent risk of removal from their homes.

ILP	Independent Living Program (DSS-transitional foster youth)
IOP	Intensive Outpatient Program
ITP	Individual Treatment Plan
LCT	Local Care Team - The role of the LCT is to ensure that community alternatives have been exhausted before a child is placed in institutional care. If appropriate, community services will be developed to prevent placement in institutional care.

MEPA	Multi-Ethnic Placement Act - prohibits the delay or denial of a foster or adoptive placement based on the race, color, or national origin of the prospective foster parent, adoptive parent, or child.

Multi-D	The Multi-Disciplinary Team - the purpose is to discuss cases from Child Protective Services or LCT that have multi-agency involvement.
